3. CEO Report

Jacques Messier updated the Board on his recent visit, along with Dr. Linda Jacobson, to Fondation Caramel in Quebec where the THS has been assisting with a hoarding situation. To date, the THS has taken in 420 animals from Fondation Caramel, as well as providing extensive food, veterinary care and managerial guidance.

He reported that in response to the Hurricane Harvey crisis in Texas, the THS is working with a New Jersey shelter in partnership with the Humane Society of the United States to receive animals that were already in shelters there, in order to free up capacity for the animals coming in as a result of the hurricane. The Board complemented Jacques on this initiative.

Jacques advised that Chateauguay, Quebec, one of the first cities to implement breed-specific legislation (BSL), has now rescinded it. Montreal, however, has recently implemented BSL.

He noted that 22 new kennel doors have been ordered, and this will complete rooms A2 and A3.

He updated the Board on the search for a canine behaviourist. With a small pool of accredited candidates, seven have expressed interest and these candidates are being contacted. With many applications for the HR manager position, interviewing will begin shortly.

Jacques was pleased to advise that Phil Nichols, Director of Operations, received the SAWA Society of Animal Welfare Administrators (SAWA) certification, one of only three in Canada who received this accreditation in 2017.

On November 24, 2017, the THS will host a gala at the Liberty Grand. Jacques encouraged the Board to support this fundraiser by attending and encouraging others to buy tickets or tables.

Jacques advised that the Volunteer Committee will meet in the fall when the new Volunteer Manager is settled in her position. The Volunteer Corn Roast will take place in September.

The Board discussed the challenges of keeping visitors from putting their fingers in animals' cages. The Animal Welfare Committee will develop a positive communications message to visitors asking them to respect the animals' space and prevent transmission of disease by refraining from putting their fingers in cages.

4. Whistleblower Policy

Bronwen Morgan reviewed the history of the Whistleblower policy. The proposed draft was designed to tighten the policy, establish criteria, evidence, and protections for both respondent and complainant. Suggestions made will be reviewed by the Governance Committee.

5. Committee Updates

There were no Committee updates, but it was queried whether there should be an Issues Oversight Committee (IOC). Board members were asked to provide their views on whether to establish an IOC.

The Board moved in-camera at 8:00 pm, rising at 8:15 pm.
