The following agreement is made between Toronto Humane Society and the undersigned owner or his/her authorized representative, hereafter referred to as the "owner/agent".

- The veterinary facility agrees to provide to the animal(s) described below, free of charge, vaccinations and physical examination (if needed) for admittance into the veterinary facility or placement with a pet foster parent. The veterinary facility will be giving custody of the animal(s) to a pet foster parent who will enter into an appropriate agreement with the veterinary facility prior to taking custody of the animal(s).
- 2. Toronto Humane Society retains the right to refuse to accept, or refuse to place with a pet foster parent, any animal(s) that, in the opinion of facility staff, endangers the health of other animals and/or the safety of facility staff or the pet foster parent and his or her family.
- 3. The owner hereby certifies that she/he is the owner of the animal(s) described below, and agrees to allow Toronto Humane Society to provide any and all veterinary care including, but not limited to, diagnostic, therapeutic, surgical, preventative treatment or euthanasia as may be deemed appropriate by the attending veterinarian(s), for the duration of this agreement. Prior approval for such treatments will be obtained by the Toronto Humane Society from the owner or authorized agent, where possible.
- 4. The owner/agent acknowledges that the attending veterinarian(s) has an obligation pursuant to the Ontario Society for the Prevention of Cruelty to Animals Act (the "Act") to report abused, neglected or an animal in "distress" (as defined under the Act) to an inspector or an agent of the Ontario Society for the Prevention of Cruelty to Animals.
- 5. The owner/agent hereby provides a full and final release of Toronto Humane Society liability including any assigns, parents, subsidiaries, affiliates, directors, officers, veterinarians, employees, or agents of the Toronto Humane Society, as applicable (collectively, the "Releasees"), from any and all claims, liabilities, demands, obligations, damages, actions, causes of action, suits, debts, charges or complaints of any kind whatsoever (including any loss or damage not yet ascertained) which the owner/agent may now have, ever have had or hereafter may have against the Releasees including, but not limited to, by reason of loss of or injury to the animal(s), the rendering or failure to render medical care, or relating to the placement of the animal(s) with a pet foster parent.





- 6. In the event that the animal is placed with a pet foster parent, the owner/agent must provide Toronto Humane Society with at least 3 business days advance written notice if the owner/agent would like Toronto Humane Society to retrieve the animal(s) for the purpose of enabling the owner/agent to remove the animal(s) from the veterinary facility. The animal(s) must be removed from Toronto Humane Society immediately following its retrieval from the pet foster parent.
- 7. The owner hereby agrees that she/he is responsible for:
  - a) removing the animal(s) from the veterinary facility immediately upon:
    - i) the termination of this agreement pursuant to paragraph 9.
- 8. The owner/agent understands that ownership of the animal(s) will transfer to Toronto Humane Society if:
  - a) left at Toronto Humane Society as a result of the failure of the owner to remove the animal(s) as required in paragraph 6 above; or
  - b) a period of 365 days has elapsed since the signing of this waiver and the animal has not been re-claimed by the owner
- 9. Notwithstanding any other provision contained herein to the contrary, this Agreement may be terminated as follows:
  - a) by mutual written agreement of Toronto Humane Society and owner at any time;
  - b) by Toronto Humane Society without cause at any time upon 30 days' prior written notice to the owner;
  - c) by the owner without cause at any time upon 3 business days' prior written notice to Toronto Humane Society;
  - d) by Toronto Humane Society for "cause" at any time by giving written notice thereof to the owner. For the purposes of this agreement, termination for "cause" means:
    - i) the breach by the owner of any of its obligations under this agreement;
    - ii) the veterinarian has exercised its rights pursuant to paragraph 2 and there are no other animals of the owner cared for pursuant to this agreement;
    - iii) the owner refused veterinary care or treatment pursuant to paragraph 3; or
    - iv) in the event the animal is considered abandoned pursuant to paragraph 8 and there are no other animals of the owner/agent cared for pursuant to this agreement; or
  - e) upon the retrieval of the last animal from the veterinary facility by the owner.
- 10. Upon termination of this Agreement:
  - a) the veterinary facility shall immediately cease the performance of all services, treatment(s), veterinary or foster care or any other matter conducted pursuant to this Agreement;
  - b) the animals shall be immediately returned to the owner/agent;
  - c) the owner/agent acknowledges that paragraphs 4, 5, 7 and 8 shall survive the termination of this agreement indefinitely.
